\*Although the express language of Section 7-10(i), which applies in this instance, requires not less than 10% nor more than 16% (or 50 more than the minimum, whichever is greater) of the primary electors of the candidate's party in the ward, the U.S. Court of Appeals for the Seventh Circuit held in *Gjersten v. Board of Election Commissioners for City of*
